Motion to approve the January 10, 2019 minutes was made by Rodester Brandon and seconded by Rev. Richard Dunn. Motion passed unanimously, 22-0.

#### **Program Services and Childhood Health Committee Report**

**Resolution 2019-36: Motion to approve the resolution was made by Dr. Susan Neimand and seconded by Steve Hope.** Authorization to negotiate and execute contracts with the University of Miami, Be Strong International, Inc., and Florida International University, to deliver brief parenting workshops, educational or public health events, in a total amount not to exceed \$1,295,868.00, for an initial term of 17 months, commencing March 1, 2019 and ending July 31, 2020, with three remaining 12-month renewals, subject to annual funding appropriations. **Motion passed, 21-0. Recusal by Dr. Daniel Bagner.** 

Resolution 2019-37: Motion to approve the resolution was made by Mary Donworth and seconded by Steve Hope. **Description of Services:** Armstrong Creative Consulting, Inc., will plan and execute the 2019 Children's Trust Family Expo, the largest community resource fair in Miami-Dade County with more than 200 exhibitors attracting 15,000-20,000 people annually. The planning and execution of this event are very fluid involving dozens of details that are under constant supervision by The Children's Trust staff. Event planning services to be provided include, but are not limited to:

- managing and tracking exhibitor registration;
- providing live and online customer support to exhibitors throughout the registration; process, leading up to the event, during setup before, and breakdown afterward;
- applying for and securing all permits and inspections;
- hiring security;
- coordinating and managing up to 100 volunteers;
- obtaining estimates, paying for, scheduling and managing the execution of all décor, AV services, entertainment and educational/interactive special areas;
- selecting and managing an event food vendor for the public and volunteers;
- ordering all on-site event signage and programs;
- hiring and managing all event staff;
- collaborating with the Miami-Dade County Fair and Expo Center on all event logistics and requirements, including obtaining insurance certificates from exhibitors;
- overseeing all aspects of the event and troubleshooting all issues that may arise; and
- reconciling all event expenses.

**Background:** In March 2016, The Children's Trust issued a request for qualifications (RFQ), #2016-06, seeking applicants for a three-year vendor pool for media and event planning services to commence on October 1, 2016. Armstrong Creative Consulting, Inc., a minority-

owned business, was one of 15 agencies selected, from 30 applicants, to join the 2016-2019 communications vendor pool. Of the three agencies in the vendor pool approved to provide event planning services, it is the sole vendor available to produce this event. Of the other two approved event planning vendors in the pool, Sweet Plans advised staff that it did not possess the capacity to plan an event of this magnitude and WOW MKTG disclosed a conflict that precluded it from submitting a bid for this event. Armstrong Creative Consulting, Inc., has served The Children's Trust for more than nine years and has successfully planned and executed the Family Expo for the past three years. The dollar amount stated in this resolution reflects a \$10,000.00 increase above the amount allocated in the FY 2017-2018 budget for the same procured services, due to costs incurred by increased security measures identified for the next event in September 2019.

**Budget Impact:** Funding in the amount of \$50,000.00 for this resolution is

allocated for FY 2018-19.

**Background:** The printing and distribution of The Children's Trust's monthly parenting newsletter is a detail-driven, precisely timed project. It involves production and delivery of the newsletter to 85 different locations, reaching more than 22,000 readers. In response to a competitive solicitation completed in June 2018, three qualified vendors provided similar quotes. Rex Three, Inc., was selected for this contract because of its experience in consistently and reliably fulfilling complex print work. Specifically, The Children's Trust regularly uses Rex Three, Inc., for print services. It has always performed with excellence and it provides timely, reliable and professional service. The other two competing vendors were unable to provide appropriate documentation demonstrating their ability to complete this work on a monthly basis while adhering to the standards required by The Children's Trust. More specifically, the other applicants failed to provide samples and references for past print work and delivery produced and executed on a similar level.

The retroactive authorization is being requested because The Trust initially expected to incur costs exceeding \$50,000.00 for the printing and preparation of the monthly parenting newsletter. A purchase order was being used to pay for the printing services of which \$17,007.00 has been expended. With the expected historical costs being above \$50,000.00, it was the intention to release a request for qualifications (RFQ) for this service to comply with the procurement policy. However, due to limited capacity and prioritization of other solicitations, it was decided to save costs by combining the December 2018 and January 2019 issues for a special year-end issue thereby decreasing the print project by a month and concomitantly reducing the annual cost to below \$50,000.00. Due to this reduction, the formal competitive solicitation is no longer necessary. In accordance with the procurement policy, purchases of goods and services up to \$50,000.00 require a three-quote process, and three quotes were obtained. Rex Three, Inc. was subsequently selected to continue providing the services.

**Description of Services:** Rex Three, Inc. will be responsible for printing, sorting, boxing, labeling and prepping for delivery of The Children's Trust monthly parenting newsletter, a trilingual publication (English, Spanish, and Creole), distributed to 85 locations throughout

**Budget Impact:** There is no budget impact for this action.

**Description of Services:** The Together for Children initiative is a countywide collaborative and systematic approach to serve children and youth who research indicates may be at greater risk of being perpetrators and victims of violence because of factors that include, but are not limited to, chronic absenteeism, poor academic performance and behavioral problems. Together for Children engages government agencies, educational institutions, law enforcement agencies, the justice system, the business community and funding entities to reduce youth violence by identifying such children and youth and providing them with prevention and intervention services. Together for Children seeks to serve three geographic regions in Miami-Dade County (County) (north, central and south), spanning 20 zip codes.

Together for Children is comprised of the iAttend Truancy Prevention Program, Middle School Prevention Program and One Stop Educational and Community Service Center. The Children's Trust contracts with the County to provide funding for the iAttend Truancy Prevention Program. Likewise, the County contracts with Miami-Dade County Public Schools (M-DCPS) and the Foundation for New Education Initiatives, Inc., (Foundation) to provide funding for a program coordinator and the implementation of the iAttend Truancy Prevention Program and funding for two interventionists and two wrap around specialists and in-kind services for four juvenile assessment counselors working for the Middle School Prevention Program and One Stop Educational and Community Service Center.

Together for Children launched in October 2016 and in July 2017, professionals were hired and work with children and youth commenced. From July 2017 through January 31, 2019,

the Foundation billed the County for employees to be paid an hourly wage for 40 hours per week. However, the Foundation, has subcontractor agreements with the 16 interventionists, two data specialists, and program coordinator that provide for payment based on deliverables, not an hourly wage. This discrepancy was identified in December 2018, through an audit of the County's contract with M-DCPS and the Foundation. Said audit has not been finalized.

This amendment is necessary to conform: (A) the budgets and scopes of services of the County's contracts with (1) The Trust, Contract #SPB-1821-7600 (Contract) and (2) M-DCPS and the Foundation to the Foundation's payment practices for and classification of 16 interventionists, two data specialists, and program coordinator; and (B) the County's Contract with The Trust to its contract with the Foundation and M-DCPS.

**Action**: Amend Contract #SPB 1821-7600, as more specifically provided below, by amending Section B. Scope of Services, Section O. Records, Report, Audits and Monitoring, and Section Y. Totality of Contract/Severability of Provisions, and Attachment B to the Contract and deleting Attachment A and replacing Attachment A with Attachment A-1.

**Description of Services:** The Children's Trust early learning quality improvement system (QIS) builds on Florida's current strategic investments to improve the quality of early learning programs for children at the highest risk of school failure. This funding seeks to customize and address the financial challenges of child care providers in low income/high-need ZIP codes, resulting in higher quality programming for children. The Children's Trust established targeted investments and processes designed to address local challenges and needs. Funding for the achievement and maintenance of quality standards is available to early learning providers through a payment differential and child scholarship slot payments. The Early Learning Coalition of Miami-Dade/Monroe (ELC) has a contract with the State Office of Early Learning (OEL) to administer school readiness payments, Gold Seal payments and administer the Early Learning Performance Funding Project and HB 1091 in Miami-Dade County. HB 1091 was adopted on March 30, 2018 with an effective date of July 1, 2018. The Children's Trust can leverage state funding through this coordinated approach.

The child care payment differential and the value of the child scholarship slot is established based on the level of quality, as measured by the Classroom Assessment and Scoring System (CLASS) tool, a research-based observational system to measure teacher-child interactions. Child care providers have access to separately-funded quality improvement supports from the Early Learning Coalition, including professional development, accreditation supports, and onsite technical assistance and coaching. The funding in this resolution supports more than 11,700 children in early learning programs.

Child scholarship slot payments address the early learning capacity issues in our community. Because Miami has a significant oversaturation of the childcare market, coupled with low payment rates for children receiving school readiness subsidies, providers are significantly challenged to meet and maintain high-quality standards. The Children's Trust will offer guaranteed payment for slots in high-quality programs, to serve children not otherwise served by the school readiness program. The Children's Trust child scholarships help children who

become ineligible for a school readiness subsidy during the school year, families that have income up to 300% of the federal poverty rate, children on the school readiness waitlist or children and families referred from one of our funded programs. To date, 93 families have received a child scholarship and enrolled their child at a Tier 4 or Tier 5 early learning program.

Licensed child care programs that meet all of the following criteria qualify to participate in the early learning QIS: 1) serve 30% or more young children receiving a school readiness subsidy, 2) are located in a low-income neighborhood, and 3) serve infants and toddlers. There are currently 189 programs participating in the early learning QIS and the distribution across the various tiers is presented in the table below.

**Background:** The Children's Trust continues to refine its approach to make high-quality child care accessible in all neighborhoods, especially less resourced areas with limited access to such quality, and ensure children are ready to learn when they enter- kindergarten. We will refine strategic investments based on the current landscape, research-proven strategies, as well as the current realities of the child care market. This is inclusive of leveraging Florida's current strategic investments to improve quality for children at the greatest risk of school failure through the Early Learning Performance Funding Project and HB 1091.

Request for Procurement Waiver (requires approval of a 2/3 vote of board members present): This resolution is requesting a waiver of the procurement process and is seeking the authorization to negotiate and execute a contract with the ELC to administer tiered payment differentials and child scholarship slot payments to early learning providers that meet various quality-level thresholds for contract year 2019-20. The ELC was created by Florida Statute to enact school readiness programs and administer federal, state and local funds allocated by the State Office of Early Learning (OEL) within the Agency for Workforce Innovation (AWI) for subsidized child care in Miami-Dade and Monroe Counties. As such, it is the sole entity responsible for administering all state and federal child care payments to early learning providers and thereby necessitates the need for this waiver request.

**Description of Services:** The Children's Trust is committed to improving the quality of early learning child care programs throughout Miami-Dade County, resulting in better outcomes for young children and ensuring their readiness for school. These outcomes are accomplished, in part, through the Early Learning Career Center (Center), which provides early learning educators with opportunities to advance their education and professional development, and ultimately improves teaching practices and interactions with children.

The Center supports the creation of a qualified, well-trained early learning workforce in Miami-Dade County through a comprehensive professional development system. There are approximately 1,700 licensed child care programs in Miami-Dade County, and all have access to career center supports. The Children's Forum will manage the Center, provide career advising services, administer scholarships to early learning educators and administrators, and ensure that training and education received by practitioners are tracked in Miami-Dade County's Professional Development Registry. The Children's Forum will also analyze data and report salient findings regarding the status of the early learning workforce, changes in education levels and certifications, and the use of professional development supports.

From August 2018 through January 2019, the Children's Forum awarded 1,016 scholarships to early learning educators. Our analysis of the program showed that educators accepting more scholarship and wage supplement dollars, having higher education levels, holding degrees, and remaining in the quality improvement system longer had higher teacher-child interaction scores on the Classroom Assessment and Scoring System tool.

**Background:** The Children's Forum is a statewide, not-for-profit organization, focused on making Florida a state where children grow and thrive in quality environments and where families have access to information, resources and options to assist them in their parenting roles. Through a broad array of programs, research and education, The Children's Forum is

committed to achieving their vision by targeting and supporting those who care for and educate children daily—the early care and education workforce.

On April 9, 2018, The Children's Trust released a request for proposals, RFP #2018-06, for an early learning career center and scholarship administration for a five-year funding cycle. Through the competitive solicitation, the Children's Forum demonstrated their capacity, expertise, and qualifications to provide the services. It has successfully operated the Center since 2007.

**Description of Services:** The Child Care WAGE\$ Florida program per the national wage subsidy and incentive program helps early learning programs in Miami-Dade County attract and retain more educated practitioners. Higher practitioner wages are linked to program retention, and staff stability allows programs to improve quality over time successfully. In addition, children benefit from stable relationships with caregivers they know and with whom they form trusting relationships. Both elements are critical to optimal child development. Teacher and program director competency and stability are directly related to children's learning gains. Preschools with highly qualified and well-paid teachers are better equipped to narrow the achievement gap.

Currently, 575 practitioners in 189 programs are receiving wage supplements from the Child Care WAGE\$ Florida program in Miami-Dade County. These practitioners have a turnover rate of 14 percent, as compared to a national turnover rate of approximately 30 percent. More than 85 percent of participating practitioners in the wage supplement program for two or more years improve their education level by one level or already have an AA degree in child development or higher.

Key components to be delivered by The Children's Forum include:

- manage the entire WAGE\$ program with counselors who meet with participants and center directors, review eligibility for payments, verify credentials and discuss with teachers' strategies to ascend the salary scale; and
- maintain accurate records and submit detailed check requests to The Children's Trust.

**Background:** The Children's Trust has funded the Child Care WAGE\$ Florida program for the past 13 years. During 2018, 901 early learning practitioners received salary supplements. The 2017 Miami-Dade Workforce Study found that early learning educators have higher quality interactions with children in their classrooms when they hold degrees and accept more scholarships and WAGE\$ supplements.

The Children's Forum holds exclusive distributor rights and is the sole licensee in Florida for the Child Care WAGE\$ Florida program. As such and per The Children's Trust's procurement policy section 2000. General Purchasing and Procurement Policy, Exemptions to Formal Competitive Procurement Process (G-4, single source purchases), a competitive solicitation is not required.

**Description of Services:** WELS is a comprehensive data system for early learning quality rating improvement systems. It has a proven track record of:

(1) integrating data from diverse data systems;

(2) providing an easy system for child care providers, quality improvement coaches, and other stakeholders to streamline and improve the quality improvement process; and

(3) tracking early learning classroom and program data over time to facilitate determination of child care program quality and evaluation of return on investments that improve program quality and workforce professional development.

WELS data will be loaded into The Children's Trust's Integrated Data Repository to measure the impact of the quality improvement supports for early learning programs in Miami-Dade County.

**Background:** In 2004, The Children's Trust board of directors voted to establish Quality Counts, a quality rating and improvement system for early care and education programs that aimed to improve the quality of child care and in turn improve children's readiness for school. In August 2018, The Children's Trust introduced a new Thrive by Five early learning quality improvement system (QIS) which supports early learning programs through tiered payment differentials, child scholarships, teacher scholarships and training, and a salary supplement program.

The long-term goal of the Thrive by Five QIS is to create a coherent, coordinated early childhood education system in the community to ensure that all children have access to high-quality early learning programs and are ready to learn upon entering kindergarten. The initial investment to co-develop WELS was extensive and the current vendor maintains the existing system for a relatively minimal cost. The system development was initially funded by the Early Childhood Initiative Foundation/Ready Schools Miami from a Kellogg grant at the cost of \$900,000.00. Once the Quality Counts system launched in January 2008, The Children's Trust assumed the costs for the maintenance, support and continued development. Since then, The Children's Trust has invested approximately \$250,000.00 per year for maintenance and support, data integration services and assessments and continued system development.

The system holds data for more than 500 early learning programs, and it would be very costly to replicate the system or transfer all of the data to a new system. Additionally, given the time and expense, it would take to implement a brand-new data system, it is not practical nor economical to re-bid the data system at this time.

**Description of Services:** The Professional Development Registry (PDR) is a data management system for tracking the size and accomplishments of the early learning workforce, including educational achievements, career advising activities and scholarships. This system provides a vehicle for answering key questions about the workforce, such as trends across settings, training, levels of education, workplace conditions and compensation, and diversity and longevity of the workforce.

The PDR has collected and verified staff qualification documentation for all early learning practitioners participating in Trust quality improvements efforts since 2007. There are currently more than 2,600 active practitioners in the PDR. The data system produces records to validate and verify qualifications and ongoing professional development for licensing, program accreditation, wage incentives, and credentials.

The existing PDR contract with The Children's Forum expires on July 31, 2019. This resolution seeks authorization from the board to waive the competitive procurement process for the PDR for Miami-Dade County's early learning practitioners and to execute a new contract with The Children's Forum for its continued administration of the PDR.

Key components to be delivered include:

- maintenance of and enhancements to the data management system;
- maintenance of a website for practitioners with an online community training calendar of classes, as well as information about local education institutions and their training and education programs;
- verification of all educational and continuing education records submitted by early learning educators;
- management of all data for the staff qualifications and educational achievement of early learning educators in Miami-Dade County, including producing a comprehensive Workforce Report; and

**Description of Services:** The Early Discovery program serves young children exhibiting mild developmental delays (10-29 percent) that are not severe enough to meet state eligibility criteria for federal IDEA early intervention services but need early preventive services. Children are referred for early intervention services through Early Steps (for children under 36 months screened for Part C services) or Florida Diagnostic and Learning Resources System (FDLRS for children 36 months and older screened for Part B services). Through Early Discovery the University of Miami Miller School of Medicine conducts follow-up developmental domain-specific assessments for speech/language development, fine and gross motor skills, and social/emotional/behavioral development.

Following the assessment, Early Discovery staff offer short-term speech/language therapy, occupational therapy, and behavioral and developmental intervention in the area(s) of concern. The program provides services for children with mild developmental delays typically range from 12 to 16 sessions, as indicated in the child's care plan and determined by need. Sessions are held one to three times per week for 30 to 60 minutes.

During contract year 2017-2018, 524 children received short-term intervention for an average of 12 sessions.

Additionally, Early Discovery offers care coordination to families, follow-up with parents and a needs assessment of the child and family. The Early Discovery care coordinator ensures all early intervention assessments are completed and services are provided, as well as coordinates timely follow-up assessments and referrals for other community resources, as needed. Early Discovery assists families with health insurance coverage (including Medicaid and private insurance) for early intervention services. If a family has insurance, Early Discovery helps them navigate the insurance process and pays solely for services not covered by the insurance provider.

**Background:** On April 9, 2018, The Children's Trust released a request for proposals, (RFP) resolution #2018-05, for comprehensive early intervention services for a five-year funding cycle. UM consistently demonstrates its capacity, expertise and qualifications to provide comprehensive short-term early intervention services for a total of 520 children per year. During the first six months of the current contract term UM has served 266 children. It has successfully operated Early Discovery with Trust funding since 2007.

**Description of Services:** Miami-Dade County Public Schools (M-DCPS) or Florida Department of Health Early Steps program identify children who need specialized evaluation due to complex behaviors and symptoms that suggest the presence of ASD. This funding is for comprehensive psychoeducational diagnostic evaluation services, based on a reduced unit cost, for children ages two through five years (prior to kindergarten entry). The diagnostic evaluation services include the following components, in alignment with the current Diagnostic and Statistical Manual of Mental Disorders and best practices (Huerta & Lord, 2012):

- behavioral observations targeting social interaction, social communication skills and restricted or repetitive patterns of behavior, interests or activities across settings:
- a social/developmental history based on an interview with parent(s) or quardian(s);
- a psychological evaluation that includes assessment of academic, intellectual, social-emotional and behavioral functioning, as well as at least one standardized instrument specific to ASD, such as the Autism Diagnostic Observation Schedule (ADOS) (Lord, et al., 2000) and/or the Autism Diagnostic Interview, Revised (ADI-R) (Le Couteur, et al., 2003);
- a language evaluation that includes assessment of the pragmatic (both verbal and nonverbal) and social interaction components of social communication;
- an observation of the child's social communication skills by a speech-language pathologist;
- a standardized assessment of adaptive behavior; and
- a functional behavioral assessment.

**Background:** UM-NSU CARD is one of seven state-funded, university-based outreach and support centers in Florida dedicated to optimizing the potential of people with ASD. Per The Children's Trust's procurement policy section 2000. General Purchasing and Procurement Policy, Exemptions to Formal Competitive Procurement Process (G-3), health services involving examination, diagnosis and treatment are exempt from a formal competitive

procurement process and therefore do not require a formal solicitation. UM-NSU CARD has been implementing the program for the past three years and is satisfactorily meeting all contractual requirements. UM-NSU CARD has worked collaboratively with Miami-Dade County Public Schools, Early Steps and The Children's Trust to develop the referral criteria and processes to ensure children in need of specialty evaluation services without other means of accessing them are identified and referred for evaluation. In addition, reporting processes have been established to track the use of diagnostic results for appropriate school placement and special education services.

This contract is based on a unit cost method of payment of \$2,300.00 per comprehensive psychoeducational diagnostic evaluation. This is a reduced rate from the standard fees at UM-NSU CARD for providing comprehensive evaluations of \$2,800.00 per child. The table below summarizes the services provided during contract year 2017-2018 and to date in the first five months of the current contract.

**Description of Services:** The comprehensive vision program, implemented by Miami Lighthouse for the Blind and Visually Impaired, Inc., (MLB) is designed to provide eye examinations and prescription eyeglasses to 4,348 eligible pre-school and school-age children which is an increase of 8.7 percent of the population previously served.

The primary goals of this program are the early detection of vision impairments, the facilitation of access to vision care, and the promotion of optimal visual functioning to ensure students succeed academically and socially. Services are delivered using two family-centered approaches such as the instant vision program (IVP) and the voucher program. Through the IVP four mobile clinics are dispatched to various schools daily to conduct comprehensive eye health and vision examinations and prescribe glasses to financially-disadvantaged children referred by Miami-Dade County Public Schools (M-DCPS), The Trust's school health staff, and parents. The voucher program (in-office) provides free eye exams and eyeglasses through vouchers dispensed by MLB and accepted by local participating optometrists. Services are currently being provided to 4,348 children enrolled in M-DCPS and pre-school age children.

This contract is paid on a unit cost of \$92.00 per exam. The actual cost of the eye exam and glasses is \$181.00 per child. MLB leverages other funds from various sources, such as The Miami Foundation, Florida Department of Health and the Dr. John T. MacDonald Foundation to the four vans and other populations beyond the one targeted by Trust funding. The table below highlights the services provided during the 2017-18 contract year.

**Background:** The National Health Interview Survey by Child Trends found, for children under age six, 32 percent of all children without health insurance did not have a well-child visit, which typically includes a vision screening. This is four times the eight percent rate of insured children without well-child visits (Child Trends, 2014). Early identification of vision problems facilitates school achievement and child health outcomes. National adolescent health survey data reveal more than 90 percent of visual impairment among 12 to 19-year-olds is due to uncorrected refractive error, which is easily remedied by eyeglasses.

**Recommended Action:** Authorization to negotiate and execute renewal contracts with six

providers for comprehensive school-based health services, each for a term of 12 months, commencing July 1, 2019 and ending June 30, 2020, in a combined total amount not to exceed \$16,250,000.00; and also requesting authorization to use funds from this initiative to leverage federal funding through the Low-Income Pool program

(LIP).

**Budget Impact:** Funding in the amount of \$16,250,000.00 is allocated for FY 2018-

19 and is projected to be available in FY 2019-20. There is no budget

impact for LIP.

**Description of Services:** The school health program is implemented in 141 public school sites in collaboration with Miami-Dade County Public Schools (M-DCPS) and the Miami-Dade County Health Department (M-DCHD). The school health teams consist of 77 social workers, 40 mental health professionals, 66 registered nurses (RN), 112 licensed practical nurses (LPN) and 16 health aides/medical assistants. High school sites are staffed with RNs with required bachelor's degrees. Middle schools are staffed by a pool of nurses that includes one RN who is assigned to two schools and an LPN. Each elementary school is assigned one full-time LPN. All LPNs are provided oversight from a rotating RN, which includes ongoing consultations, review of clinical notes, observations of LPN encounters and shadowing.

Essential nursing care, disease prevention and health promotion activities provided under the program include:

- nursing care; medication administration and assistance with self-administration;
- chronic disease management, including one-on-one education for children with chronic conditions such as asthma, diabetes, severe allergies, seizures and sickle cell;
- state-mandated screenings such as vision, Body Mass Index (BMI); oral health risk assessment, health education, disease prevention counseling based on individual health needs and school climate, and fluoride varnish application; and
- referral and connection of families with needed community services and resources, including other programs funded by The Children's Trust.

Behavioral health services, delivered by social workers and mental health professionals, include screening, assessment, and intervention for students with developmental and behavioral concerns, as well as preventive education and support services that promote a healthy school climate. The funded agencies provide a multi-tier model of services that include schoolwide and

small group interventions, as well as intensive interventions for individual students based on need. To ensure successful implementation, school administrators and staff are involved in planning and conducting interventions.

Key mental health and social work services include:

- screenings for developmental, social, emotional and behavioral well-being for early identification of students with mental health and behavioral concerns;
- timely and responsive assessment or intervention services for at-risk students;
- individual, group and family counseling to address targeted problems interfering with students' functioning and well-being;
- risk reduction for vulnerable students by promoting awareness, responding to crises and assisting schools in reinstating a state of functional safety and security; and
- schoolwide, preventive education and supports.

The Low-Income Pool program consists of a broad allotment of state and federal funding primarily through intergovernmental transfers from local governments, matched by federal funds through the Agency for Healthcare Administration (ACHA). The objective of the LIP is to ensure continued government support for the provision of health care services for uninsured/underinsured populations. Based on state appropriations of LIP, a percentage of the contracted amount from the four Federal Qualified Health Centers (FQHCs) may be used to draw down LIP funding, through agreements between The Children's Trust and AHCA on behalf of these FQHCs. These contracts would be used as leverage to draw down the LIP funding to Miami-Dade County's most vulnerable population. Said funding will be used exclusively for the provision of health services for children in Miami-Dade County. The funded FQHCs are Borinquen Health Care Centers, Citrus Health Network, Community Health of South Florida and Jessie Trice Community Health Center.


**Background:** Physical and emotional health offer the biological platform for children to attend, learn and perform their best in school, and ultimately become contributing members of society. Most risk factors for chronic adult diseases, mental health conditions, and social challenges arise in childhood. Child health, development and well-being affect educational achievement, behavior and future employment.

Health programmatic highlights from services provided during 2017-18 school year include:

- 90,847 unique students served with 308,456 contacts;
- 85 percent (184,349) of visits to the health suites resulted in students returning to class;
- social workers completed 12,717 encounters, of which 57 percent were for counseling;
- 24 percent (72,633) of school health visits resulted in a referral, 95 percent of which were to medical providers/primary care physician;
- 36,030 students were screened for weight, and 8,072 referred for further services;
- 7,390 children were screened for oral health and 1,535 referred for further services; and
- 8,439 students with chronic conditions received nursing assessments to help determine their needs for individual health care plans and ensure the successful management of their health conditions.

**Budget Impact:** There is no budget impact for this action.

**Description of Services:** The Children's Trust funds after-school and summer camp programming for elementary school children (grades K-5) in inclusive and specialty disability programs. After-school programs operate five days per week (Monday-Friday) per Miami-Dade County Public Schools' calendar (180 days) and may also include up to 31 full days on teacher planning days, holidays and spring break, based on what was proposed in the funding application. Summer programs operate five days per week for at least ten hours per day for a period of six to eleven weeks.

Programs follow a structured schedule of activities to support academic success, social-emotional learning (SEL) and physical fitness. Certified teachers utilize evidence-based group literacy strategies, along with differentiated (individualized) small group reading instruction with children struggling with reading. Homework assistance is provided during the school year. SEL is focused on developing essential competencies and life skills. Fitness components aim to help children meet recommended levels for high-intensity activity. Children receive nutritious food and beverages, and programs incorporate family engagement. Additional skill-building activities vary across programs and may include STEM (science, technology, engineering, math), arts and culture, civic engagement and/or specialized programming for children with disabilities

On May 29, 2018, the Board approved funding for 96 programs following a competitive solicitation through Resolution #2018-71. The contract listed below requires an amendment to reflect a subcontractor change. Resolution #2017-17, approved by the board on October 19, 2016, requires board approval for contracts with changes to a subcontractor.

The City of North Miami Beach, Parks and Recreation's program is a new Trust funded afterschool and summer camp provider that serves a combined total of 135 children in three park locations in North Miami Beach. It contracted with Focus Learning Academy to provide certified teachers to deliver the literacy component of services to program participants. Focus Learning Academy is misclassified in the current contract as professional services and needs to be added as a subcontractor. The contract was fully executed on October 11, 2018 listing Focus Learning Academy as a professional service. Through the on-going quality improvement site visits, it was determined that the services provided by Focus Learning Academy are aligned to the definition of a subcontractor as opposed to professional services. The misclassification did not affect the program in any way. The proper classification in the contract will allow for a more formal agreement between the City of North Miami Beach and Focus Learning Academy since they are providing a portion of the services identified in the scope of services.

**Action:** Amend Contract #YAS-1914-7020 to reflect the addition of Focus Learning Academy as a subcontractor to provide certified teachers to delivery literacy activities.
